

# Jailed Man Gets Another 5 Months For Writing Bad Check

A 23-year-old inmate of New Hanover County Jail had another five months added to his sentence last week after pleading guilty in Brunswick County District Court to a charge of writing a worthless check to a Charlotte electronics store.

O'Larry Lampkins II of Rock Creek Road, Leland, admitted writing a check for \$105.95 to the Radio Shack store last Sept. 28, while knowing that the bank account was closed.

About a month later, a warrant was issued for Lampkins' arrest. But the deputy was unable to serve the paper because Lampkins was already in jail, court records show.

Judge Napoleon Barefoot Jr. sentenced Lampkins to five months in the North Carolina Department of Corrections to run at the expiration of any sentence he is now serving.

Barefoot presided over three days of district court last week. Assistant District Attorney Rick Green prosecuted, while Marie Jordan served as courtroom clerk.
