

Ash Man Gets Two Years For Theft Of Handgun

A 29-year-old Ash man was sentenced to a year in prison after pleading guilty in Brunswick County District Court last week to a charge of misdemeanor larceny.

The defendant, Charles Edward Stanley of Route 1, had been charged with the felonious larceny of a firearm. He agreed to plead guilty to the lesser charge as part of a plea bargain.

Stanley was arrested by Brunswick County Sheriff's Detective John Ingram for stealing a .45-caliber semi-automatic pistol owned by Willie Dean Gore last Nov. 6, according to the warrant.

Judge David Wall sentenced Gore to two years with credit for the 13 days he spent in jail after his arrest.

Wall presided over district court Monday and Tuesday. Judge Jerry Jolly heard cases Wednesday. Assistant District Attorney Rick Green prosecuted, while Marie Jordan served as courtroom clerk.
