

Holden Beach Man Sentenced To Two Years For 15 Offenses

A 33-year-old Holden Beach man was sentenced to four years in prison last week after pleading guilty in Brunswick County District Court to charges of carrying a concealed weapon, trespassing, property damage, unauthorized use of a motor vehicle, violating a court order and 10 counts of writing worthless checks.

Graham Kevin Willetts, 33, of Ocean Boulevard East admitted writing about \$400 worth of bad checks, none over \$67, and cashing them at five area grocery and convenience stores. He was given a two-year active sentence in those convictions.

Judge David Wall sentenced Willetts to another two years for carrying a concealed .380-caliber semi-automatic pistol in Sunset Beach last October.

A charge against Willetts of assaulting a female was voluntarily dismissed by the state.

The judge gave Willetts credit for 61 days spent in jail awaiting trial and recommended that he participate in the Drug Abuse Recovery Training (DART) program while incarcerated.

Judge Wall presided over district court last Monday (Feb. 28), while Judge Jerry Jolly heard cases Tuesday and Wednesday. Assistant District Attorneys Lee Bollinger and Rick Green. Marie Jordan served as courtroom clerk.
