I received the State of North Carolina Criminal Justice Training Council's Advance Law Enforcement Certificate. I have had specialized training in many areas of law enforcement such as weapons, pursuit driving, narcotics and criminal investigation.

I will bring the Brunswick County Sheriff's Department the benefits of my education and experience. I plan to extend these accomplishments to the deputies through increased training and opportunities for education. I will support the employees by seeking the best available equipment and will endeavor to reward outstanding employee performance. I believe in loyalty and devotion to law enforcement from all officers and in the camaraderie among officers.
