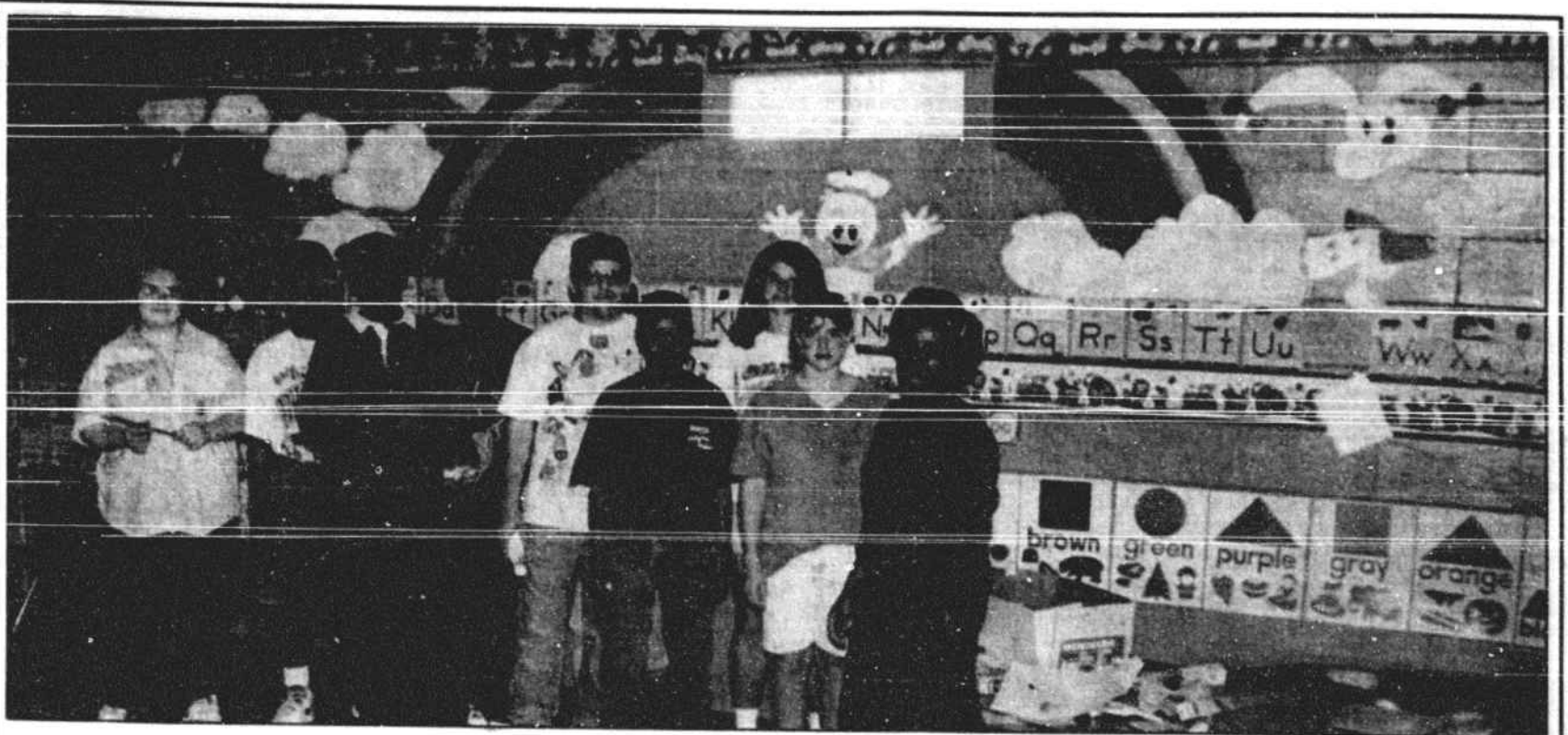

Shell Point Man Charged With Shallotte Break-Ins

Shallotte Police have made an arrest and recovered one of three boat motors that were stolen during two break-ins at Shallotte Marine Supplies in December and January.

Robert Christopher Hewett, 21, of Shell Point, was charged last Friday with two counts of breaking and entering and larceny, said Shallotte Det. Carey Gaskins.

"Warrants have been drawn on

another man in the same case but they haven't been served yet," Gaskins said Tuesday.

Gaskins said one new boat motor and two used motors were stolen during the two break-ins. The new motor has been recovered.

"We do have a lead as to where the other two are at," Gaskins said of the used motors.

Gaskins said Hewett also has

been charged with breaking and entering and larceny in connection with a recent break-in at an auto detailing and glass-tinting business.

The officer said window-tinting material was taken during a Nov. 19, 1993, break in at Sun Control Inc.

Worthless Check

Shallotte Police arrested a local man Monday in connection with an \$18,000 worthless check written last summer.

Gaskins said David Wayne Brown, 35, of Shallotte, has been charged with a felony in connection with a check written last August at Shallotte Lumber Co.

Suspect Charged

Shallotte Police also have arrested a local man suspected of stealing fishing reels and portable drills from Shallotte Electric on April 19.

Ulysses Harrington, 44, of Cedar Grove, was arrested last Wednesday and charged with possession of stolen property, Gaskins said.

Gaskins said a second arrest war-

rant in the case has been drawn but had not been issued as of Tuesday afternoon.

Radios Recovered

Shallotte police have recovered a pair of portable, two-way radios that were stolen about three weeks ago and an arrest is pending, Gaskins said.

One of the radios was taken April 23 from the Shallotte Volunteer Rescue Squad building and the other was stolen April 20 from a Brunswick County EMS ambulance parked at Autumn Care.

Stolen Car Located

Gaskins said police recently recovered a 1989 Pontiac Grand Am that was stolen Aug. 7, 1992. The vehicle was owned by Paul Wayne Miller of Shallotte.

"We recovered the vehicle in Lumberton. No arrest has been made in that case yet," Gaskins said. "It's been pretty much stripped. It was at a used car dealer in a salvage yard."
