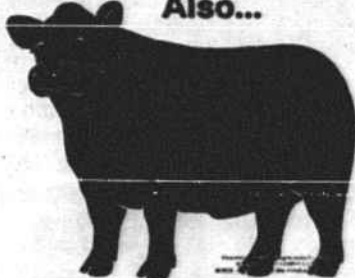

PUBLIC MEETING

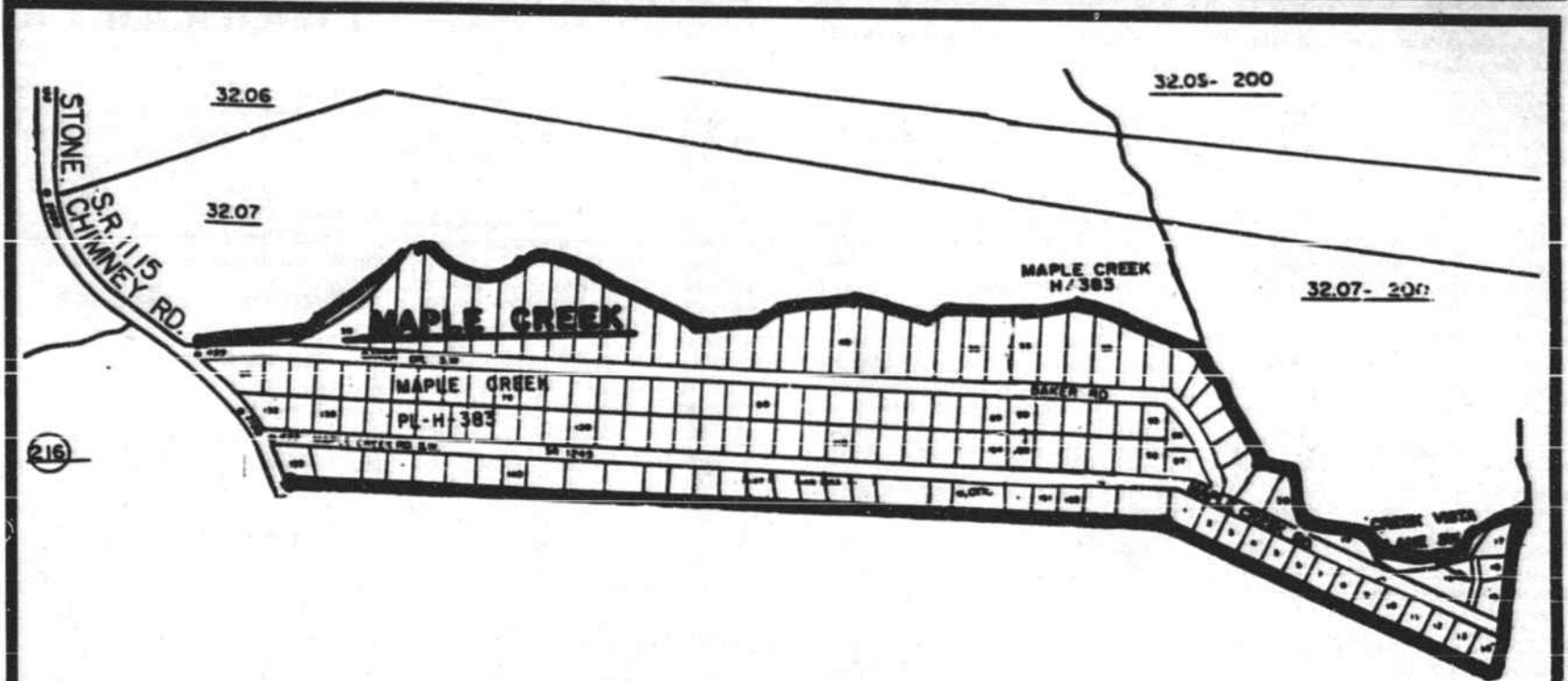
