

White Oak Man Gets 18 Days For Leaving Accident Scene

A 26-year-old White Oak man was sentenced to 18 days in jail last week after pleading guilty in Brunswick County District Court to a charge of leaving the scene of a traffic accident.

The defendant, Rodney Maurice McMillian of Route 1, pleaded guilty to a charge of misdemeanor hit-and-run, court records show.

The arrest warrant states that McMillian "failed to give his name, address, driver's license number and license plate number to the person struck" at the scene of a collision that occurred last February on U.S. 74/76 in Leland.

Presiding Judge Jerry Jolly sentenced McMillian to 18 days in Brunswick County Jail, with credit for the time he served awaiting trial.

Judge Jolly heard cases during three days of district court last week, with District Attorney Rex Gore and assistant DA Don Kelly prosecuting. Marie Jordan served as courtroom clerk.
