Shallotte Aldermen Opposing Proposed ABC Store In Ash

Shallotte officials say they feel the Brunswick County ABC Board did them wrong four years ago when it opened the first county-operated liquor store on Holden Beach Road.

Town ABC revenues dropped more than 60 percent the year after the county store opened-a reflection of how much business the county store took away from the town.

Now Shallotte officials are fuming over the idea that the county ABC board is considering opening another store in the Ash area between Shallotte and the county line.

"If they open that store in Ash and it impacts us as much as the one at Holden Beach did, we might as well close our store," Mayor Sarah Tripp said Tuesday.

Dot Kelly, manager of Brunswick County's Alcohol Beverage Control (ABC) system, said the county board will probably decide within the next few months where its third store will be located

In addition to the Holden Beach Road location, the county operates an ABC store on U.S. 74-76 near the

Although a specific site for a new store has not been decided, Kelly said the board has agreed that it should be in Ash. "They've decided on that much, to serve the people in that area," she said.

Shallotte officials hope the county board changes its mind. Town aldermen adopted a resolution last week opposing the opening of any new county ABC stores in the Shallotte area, including Ash.

Shallotte's revenues from its ABC store have plunged since the county store on Holden Beach Road opened in mid-1990.

In the five years prior to the opening of the county store, Shallotte received an average of \$64,359 in annual ABC store revenues.

The town has received \$24,000 each of the last three years, and officials anticipate only \$20,000 this fis-

"Our income from the store came way down when the one at Holden Beach opened," Tripp said. "That's a lot of money to lose in a short time." Tripp said the county ABC board

has not contacted the town about the

plan to open a new store. "I hope they will listen to us and realize before they do it," she said. "I really and truly do not think they take into account the impact to the stores in the municipalities when

they put them out in the country like Kelly said liquor sales have gone "very, very well" at the county's two existing ABC stores. She could not provide sales figures for the 1993-94

fiscal year that ended June 30.

Brunswick County Commissioner Tom Rabon, who represents Ash, said Tuesday that he was not aware of the county ABC board's plans to open a store in his district.

"It's complete news to me," Rabon said. "I haven't heard any pros or cons to that. I don't have any idea what the local populace would think.

Mayor Tripp, who was brought up in Ash, said, "I've talked to some people around Ash and they don't particularly want it."

Kelly said the county ABC board is not considering any areas other than Ash as potential store sites at

Rescuer Needed Rescuing In Sunset Beach Incident

A Rockingham man who attempted to rescue a boy from drowning at Sunset Beach ran into trouble himself Saturday evening.

sturday, in the swimming area near the Sunset Beach Pier and access area, Fred Metton, 38, went into the ocean with the intent of helping a panicked youth who had apparently been caught in an undertow off-

"Then the man got pulled under himself and some other people had to go to his rescue," said Sunset Beach Police Officer Anna Dosio, reciting a scenario all too familiar to Brunswick County emergency personnel during the summer season.

She responded to the scene along with Sunset Beach Volunteer Fire Department first responders, Calabash EMS, Brunswick Courty EMS and Ocean Isle Beach VFD's Water

When Sunset Beach first responders arrived, said Asst. Chief T.J. Lyke, a first responder, Metton was already on the beach strand. "He Between 7:30 p.m. and 8 p.m. was conscious, but drowsy," Lyke said. "We treated him there and Brunswick EMS started advanced life support."

Calabash EMS transported Metton to The Brunswick Hospital, where he received further care and was held overnight for observation and released Sunday, said Chief Executive Officer Mark Gregson of the hospital.

Metton stopped by the Sunset Beach Police Department to thank Dosio and let her see that he was

"He looked a lot better," she said. As for the boy Metton set out to help, "We don't have any idea what happened to him," reported Lyke. "He swam off."


