

Shalotte Man Sentenced To Six Years In Two Break-Ins

A 24-year-old Shalotte man was sentenced to six years in prison last week after pleading guilty in Brunswick County District Court to two charges of larceny and one count of breaking and entering.

William Raymond Kratzer of N.C. 130 West had been charged with four felonies in connection with two break-ins and the theft of more than \$13,700 worth of jewelry and other items.

In a plea bargain, Kratzer agreed to plead guilty to three misdemeanors and had the fourth charge dropped. In exchange, he was given three consecutive two-year prison sentences.

Kratzer was accused of breaking into a home on Car-Griff Road, Shalotte, last month and stealing four drawers from a jewelry box, which contained 80 pairs of gold earrings, four class rings, three wedding bands, four necklaces and other assorted jewelry. He also admitted guilt in the June 18 theft of a checkbook from a home on Al Street in Shalotte.

Kratzer was arrested the following day by Detective Tom Hunter of the Brunswick County Sheriff's Department.
