Southport Man Gets Two-Year Prison Term For Break-In

A Southport man was sentenced to two years in prison last week after pleading guilty in Brunswick County District Court to a charge of breaking into a home in Long Beach

The defendant, Richard Alvey Partello III, 26, of Route 1 had been charged with felony breaking and entering. He pleaded guilty to a misdemeanor offense as part of a plea bargain.

Judge Jerry Jolly accepted the plea and gave Partello the active sentence with credit for the 32 days he spent in jail awaiting trial.
