

WBHS Student Spends Weekend In Jail For Carrying Pot Pipe, Beer

A West Brunswick High School Student was ordered to spend 48 hours in jail last weekend after she was arrested with a marijuana pipe and a can of beer in her purse while riding around Shallotte with friends at 2:40 in the morning.

Ashley Lauren Ware, 16, of Fox Street pleaded guilty in Brunswick County District Court Thursday to one count each of possession of drug paraphernalia and possession of alcohol while under the age of 19.

Shallotte Police Officer James Sublett testified that Ware was one of several young people in a Volkswagen he stopped on Copas Shores Road in the early morning hours of Aug. 6.

A bag of marijuana was found in the car, Sublett said. Ware agreed to let Sublett look into her purse, where he found an unopened can of beer and a pipe containing "what appeared to be marijuana residue."

Judge Ola Lewis Bray sentenced Ware to a year in prison, but agreed to suspend the judgment on the condition that she perform 24 hours of community service and comply with a long list of other requirements. She was put on supervised probation for two years.

While on probation, Ware must observe a 7:30 p.m. curfew seven nights a week unless she is attending a church or school function, when she can stay out until 11 p.m. She was ordered not to associate with co-defendants in the case and to maintain at least a "C" average in school without any unexcused absences, tardiness or disciplinary actions.

Judge Bray ordered Ware to prepare a 10-page typewritten essay on her future goals and aspirations and how a criminal record might affect those plans. She was told to remain in her parents' home while enrolled in school. For the next two years, she must submit to warrantless searches and drug tests at the discretion of her parole officer.

"I want the local police to notify me if they so much as see her sitting on her front stoop at 7:31 p.m.," Judge Bray said. Speaking to Ware's mother, she added, "If you have any trouble with her, I want you to notify her probation officer and myself."

"Then pack her bag and bring her toothbrush, because she will be going to jail," the judge said.

Judge Bray presided over three days of district court in Bolivia last week. Judge Napoleon Barefoot Jr. heard cases Monday. District Attorney Rex Gore prosecuted Monday and Tuesday, while Southport attorney William Fairley acted as assistant D.A. Wednesday and Thursday. Marie Jordan served as courtroom clerk.
