Elderly Couple Killed In Head-On Collision

An elderly couple from the Shallotte area was killed last Tucsday, Sept. 27, in a head-on collision south of Shallotte on N.C. 179.

Killed were Edgar M. McKinney. 69, and his wife, Marie McKinney, also 69.

Mr. McKinney was traveling south on N.C. 179 when, at approximately 2 p.m., reported Trooper H.R. Smith, his 1977 Chevrolet station wagon crossed left of the center line and struck a northbound 1988 Chevrolet pickup truck operated by Robert Lanier, 20, of Shallotte. The accident occurred just outside the Shallotte town limits near the intersection of N.C. 179 and Village Point Road.

Lanier was treated at The Brunswick Hospital for serious, but nonincapcitating injuries.

No charges were filed.

Nor were charges filed in an accident that happened Friday, Sept. 30, 7.9 miles south of Bolivia on private property.

Clarence Harper, 81, of Wilmington, was pulling into a driveway at about 12:30 p.m. when he lost control of his 1991 Ford, according to Trooper D.B. Harvell, the investigating officer. The car struck the corner of a house, a heating unit and several trees in the yard before coming to

Damage to the property was estimated at \$1,000 and to Harper's car, \$2,000. Harper and his passenger, Ruby Harper, 77, also of Wilmington, complained of minor injuries.

Three persons received minor injuries in a two-vehicle accident that happened at 7:30 a.m. Friday 7.9 miles west of Sunset Beach on N.C. 904 between Grissettown and Long-

Jon Langston, 46, of Shallotte, was driving west on N.C. 904 in a 1989 Ford when a car operated by Lisa Alexander, 18, of Longwood, pulled out in front of him from the driveway of a store, reported Trooper D.B. Harvell.

Langston's vehicle struck the 1988 Dodge in the left front fender. Alexander was charged with failure to yield.

Damages were estimated at \$2,000 to each vehicle.

Langston, Alexander, and a passenger in her vehicle. Donella Alexander, 17, also of Longwood, were treated at The Brunswick Hospital for minor injuries.

Also Friday, a driver involved in a single-vehicle accident at 7:15 p.m. was charged with driving while impaired and exceeding a safe speed.

Benjamin Capps, 25, of Gastonia, was traveling south on N.C. 211 north of Supply at a high rate of speed, according to Trooper R.E. King, who investigated the accdent. Capps' 1986 Toyota ran off the right side of the road, traveled along the shoulder, became airborne and struck several trees before striking a ditch and coming to rest right side

Capps was transported to The Brunswick Hospital with serious, non-incapacitating injuries.

A Shallotte area woman was injured Sunday, Oct. 2, in a single-vehicle accident that happened at about 3:15 p.m. on Stanley Road (S.R. 1119).

Greta Phillips, 25, was traveling north on Stanley Road when her 1985 Chevrolet ran off the road on the right side and struck a tree, reported Trooper T.W. Caulder.


She was charged with careless and reckless driving.




