

Repeat Offender Gets 6 Years On 8 Misdemeanor Charges

A Leland man with a lengthy record of arrests and convictions was sentenced to six years in prison last week after pleading guilty in Brunswick County District Court to eight more misdemeanor offenses.

Victor Dale Sullivan, 34, of Leland Mobile Home Park, pleaded guilty to assault on a government official, resisting arrest, driving while his license was permanently revoked, failure to stop for a blue light and siren, reckless driving, speeding to elude arrest, driving while impaired by alcohol and misdemeanor larceny.

Sullivan was found to have a blood alcohol content of .11 percent when he was stopped on U.S. 74/76 at about 3 a.m. on Oct. 2 after speeding at 75 miles per hour while attempting to elude arrest for allegedly stealing a newspaper box, court records show. He was also accused of striking Brunswick County Sheriff's Deputy Michael Cierpiot on the side of the head and running from the scene.

Judge Jerry Jolly consolidated the cases into three separate judgments and sentenced Sullivan to three consecutive two-year prison terms.

In three days of district court in Bolivia last week, Judge Jolly presided, while assistant district attorneys Lee Bollinger and Rick Green prosecuted. Marie Jordan served as courtroom clerk.
