

### KNOW YOUR SOCIAL SECURITY

Earl W. Trinkle, representative of the Social Security Administration, is in Hertford the second Wednesday of each month at the Perquimans County Court House.

The Norfolk office of the Social Security Administration processed over 7,700 applications for old-age benefits last year. About 20% of these applicants earned over \$200 during the calendar year.

Many of these people did not realize that they were required to file an annual report of earnings with the Social Security Administration.

The annual report is needed to determine the number of monthly social security checks the beneficiary can draw for the year.

The earnings test of the Social Security Act permits a beneficiary to earn up to \$1200 per year and still draw all of his benefits for that year. If he earns over \$1200, there will be one or more months for which he is not entitled to benefits.

An example is a man who earned \$2400 in the first half of the year and retired on June 30th. He can file and start drawing his social security payments beginning with July as long as he does not earn over \$100 in any month in wages or rendered substantial services in self-employment.

If he should go back to work in December to help out in the

Christmas rush and earn over \$100, he would not be entitled to his payment for that month.

Regardless of whether he works or not after filing his social security payments if he earned over \$1200, he is required to file the annual report between January 1 and April 15 of the next year.

This requirement of an annual report also applies to the person who reaches age 72 and continues to work. He can draw payments regardless of earnings after reaching 72, but he still is required to file the annual report for the year in which he reaches 72.
