



Washington — When the vote on the foreign aid authorization bill last week, I found myself unable to support the measure.

The foreign aid program contains some worthy projects which I cannot discuss with sound public policy. I adequately discuss the measure in the space of the authorization, but it should be of interest to the taxpayers to know the provisions for such things as the preservation of the temples of the Egyptians on the upper Nile and the guarantee of private loans to purchasers of houses in South America. The inclusion of such projects, and the enormity of the authorization in dollars, led me to the conclusion that there could be no reasonable justification for supporting the authorization.

I voted against it. Later, the Senate will appropriate funds for foreign aid. I am hopeful that some of these items can be eliminated.

Realism Not Evident—To me it is wholly unrealistic for the Administration to advocate a foreign aid bill of over four billion dollars while at the same time calling for economy in government. I am convinced that too many borrowed dollars are being put into the foreign aid program when the public debt is increasing and our domestic programs are faltering due to lack of funds.

I do not quarrel with a mutual security program that is realistically designed and administered effectively to help develop the areas of the world that are striving to strengthen freedom against communism.

Common Sense Needed—If this country feels that it is necessary to put the foreign aid program on an ever-expanding and permanent basis, then Congress, the Administration and the taxpayers ought to face up to the reality of the issue. It will cost a lot of us who pay taxes; future generations should not be saddled with the debt that the people and their leaders of today are unwilling to access themselves.

Real Theory—As a Senator of the United States, it is my duty sincerely and honestly to tackle the problems that face the people whom I have the opportunity to represent in part. Requests for more money pour in from all activities of government; defense costs increase with regularity; education and other programs to improve the lot of our country demand attention. The money requests are not theoretical. No public funds can be expended without coming from the taxpayers or from borrowing, and I feel that President Eisenhower, the Administration and the Congress have to share the responsibility for talking about economy and failing to practice it.

The nation will have to make a very important decision in the not too distant future. As I see it, the decision is whether or not we are willing to stand up and be counted as willing to pay now for the benefits so many are demanding at home and abroad.

New Developments In Egg Production

New developments are taking place continually at the research stations throughout the nation. A number of new poultry and egg convenience products have been developed recently by one of the stations.

The products have been aimed at greater variety, time-saving and ease of use to increase consumption of poultry and eggs. Here are some of the products that will be tested on the market in the near future.

1. **Frozen French Toast**—This product offers both convenience and variety. Each slice contains a half egg. To prepare for eating simply put slices in the toaster.

2. **Young Roaster**—Excellent roasters which weigh about 3½ pounds are suited to the family of three or four, are extremely tender, and obtained from the heavier birds of broiler flocks.

3. **Kid's Pak**—Twelve small eggs in a container offered for children. This pack is aimed at better merchandising of small eggs.

4. **Family Pak**—Four large eggs for Mom and Dad along with eight medium or small eggs for the children.

5. **Chicken Loaf**—A sandwich loaf, made from heavier birds, that can take its place along with the many popular meat-leaf products on the market.

6. **Chicken Bologna**—Another use for heavier birds is this cold cut with a definite smoked flavor.

7. **Chicken Frank**—A new member of the hot dog family, the chicken frank will get its try-out some time this summer. This is a low-fat, high-protein food expected to be especially popular during the outdoor eating season.
