

The Hertford Fifes and Drums is a musical corps of 13 members from age 16 years up. The Fife and Drum Corps was formed in November 1974 to provide martial music for parades and historical civic programs. The purpose of the Corps is to perpeturate the sound of ancient fife and drum music, and to bring to life a part of our colonial history.

The Hertford Fifes and Drums Corps portrayes Field Musicks of the Perquimans County Militia of 1775 period by wearing custom tailored Colonial Militia clothes. The Corps plays authentic handcrafted rope tension snare and bass drums and straight fifes. The Unit carries a hand made replica of the North Carolina Militia Flag used in the Battle of Guilford Courthouse in 1781, also an American '76 stars and stripes flag along with a special designed unit flag. The 13 member corps, the number of the original colonies, is composed of 1 Drum Major, 3 Color Bearers, 6 Fifers, and 3 Drummers.

The Family Education Rights and Privacy Act of 1974 has been drawn up locally. Aiding those in the Perquimans school system with this policy was Ms. Susan Allen, legal advisor with the Northeast Regional Educational Center in Grifton, N.C.

School officials stated, 'The Perquimans County Board of Education recognizes the right of any parent, guardian or student who has reached age 18 to review the school record of the student. The following regulations shall be adhered to in this matter:

1. Prior to the review of a school record a request must be made to the principal to see the student's

2. Notification that the student's record is available shall be made within five who is disattisfied with the days after the request is

accuracy of any information in the record of a student will have the right to a hearing. A written request for the hearing must be made by the parent or the student. The hearing must be held within fourteen days of the receipt of the request the school's

administrative office. The hearing will be before the school principal who will be empowered to correct, delete or modify any information on the record which he decides to be incorrect or inappropriate.

6. Any parent or student

7. At any point the parent or student may choose to appeal no further but may put in the record a letter explaining his disagreement with the contested information.
