Ruling Made On National Teacher Exams

According to Palmer, the long fight waged against the NTE by the NCAE and the National Education Association has finally ended in an overwhelming victory for the teachers of North Carolina.

The decision to eliminate the NTE as a criteria for certification was handed down by Judge J. Braxton Craven representing a three-judge panel. Braxton, along with Judges Hainsworth and Dupree, declared the practice of certification of North Carolina teachers based upon NTE cutoff scores unconstitutional and discriminatory.

The decision by the panel of judges provides an injunction for the state to issue regular licenses for the plaintiff-intervenors and all other educators who are qualified for licensing except for their failure to attain the minimum NTE score requirement.

> However, the landmark decision does not prevent the state from reinstating a written test which may require a cutoff score. If the state wishes to establish such a written examination, it must have a cutoff score which has been deemed valid in measuring the minimum knowledge needed for competent teaching performance.

Palmer said he "has been working since 1964 to eliminate the NTE and that this decision is one of the high achievements of his career." "After eleven years," said the education leader, "it is gratifying to see a three-judge panel agree with what I have espoused and restores my confidence in our American judicial process. The education profession is greatly relieved from the lifting of this awesome burden, at least for the time being", said Palmer.



Conservation Planning In N.C.

Good conservation practices which are established means: 'increasing incomes and efficiency through proper land uses; protecting land against all forms of soil deteriorations; rebuilding eroded and depleted soils; building up soil fertility; stabilizing critical run off and sediment producing areas; improving grasslands, woodlands, and wildlife habitats; conserving water for agricultural and municipal as well as other uses; proper agricultural drainage and irrigation; and reducing floodwaters and sediment

Each county in North Carolina has a Soil and Water Conservation District office, with or close to a Soil

minimum wage will advance from the present \$1.80 per hour to \$2.00 per hour in establishments not covered by the Fair Labor Standards Act (Federal Wage-Hour Law)," said Commissioner Creel. "This increase will apply to employees in establishments having four or more employees.

'An undetermined number of those who will benefit from the higher minimum wage are persons 65 years of age and over," Creel added. "The General Assembly repealed the section of the law which hitherto has exempted these older people, and on Oct. 1 they will be entitled to the new \$2.00 an hour minimum

Creel said the new wage floor will benefit mostly workers employed in wholesale trade under this law."

"The General Assembly also provided the Labor Department with additional authority to help collect back wages due employees under the Minimum Wage Law," Commissioner Creel stated. "The newly enacted North Carolina Uniform Wage Payment Law, which will become effective January 1, 1976, will be a great help to us in insuring that employees covered by the Minimum Wage Law will receive the wages to relatively small retail and which they are entitled
