Multiple Sclerosis is a neurological disease affecting the brain and spinal cord. It is not contagious nor is it a mental disease. It has been called the 'mysteriouscrippler of young adults' because it is usually first diagnosed between the ages of 15 and 50.

Technically, the disease attacks the myelin sheathing of the central nervous system, destroying it in patches. The myelin sheath acts much like the insulation around telephone wires, and when it is destroyed, the flow of nerve impulses to and from the brain are interrupted

Albemarle Museum to host dig site tour

Join the Museum of the Albemarle and the North Carolina Museum of History Associates for a special tour of a Chowanoke Indian Archeological Site on June 7, 1984.

Dr. David Phelps, professor of Anthropology at East Carolina University and renowned North Carolina Indian authority is presently excavating the remains of a Chowanoke Indian village, near Harrisville on the Chowan River. He has graciously invited the Museum and Associates to bring a group of interested individuals on-site to learn more about our "native Americans".

The charter bus will depart from the Museum of the Albemarle at 8:15 a.m. Arrival at the dig site is scheduled for 10:00 a.m. Dr. Phelps will conduct a tour of the site highlighting and presenting informative data on the existence of the Chowanoke Indians. At 12:00 noon, the group will travel to nearby Ahsokie, arriving at the Jenkins House Restaurant, a restored

historic structure, for a leisurely lunch. After lunch, the bus will travel back to Elizabeth City, with arrival time at the Museum slated for 3:30 p.m.

Total cost for the day, including tour and lunch, will be \$12.00, payable in advance. Please send check or money order to the Museum of the Albemarle, Route 6, Hwy. 17 South, Elizabeth City, NC 27909 and make payable to the North Carolina Museum of History Associates. Registration will be on a first come, first serve basis. A maximum of 46 people will be accepted, and a waiting list will be kept in the event of cancellations.
