Mr. C. O. Bumgarner, town councilman from Ward 1 and for 21 years a resident of Mooresville, was made quite happy Tuesday, when two of his boyhood friends dropped in to spend the day. Mr. Bumgarner is a native of Alexander county, but when quite a lad went over to Catawba county, where he stayed a brief spell. But while he was in Catawba county he formed some strong friendships with other boys of that community, among them being M. P. Harmon and R. S. Thornburg. They became separated, each going his own way. At a hospital in Charlotte during the Christmas holidays Mr. Bumgarner met a lady from Kings Mountain and in conversation the name of Mr. Harmon was mentioned. When the good lady returned to Kings Mountain, she looked up Mr. Harmon and told him of meeting with a friend of his boyhood. Mr. Harmon got in touch with Mr. Thornburg, and on Tuesday the two men came up from Kings Mountain and spent the day with Mr. Bumgarner. They had not seen one another for 49 years. The conversation lasted throughout the day referring to their varied experiences since they parted in Catawba county.—Mooresville News-Leader.
