Many domestic workers are unaware that the employers are not filing a proper report of these wages. Barkley pointed out that unless this report is filed with the Internal Revenue Service, domestic workers will not receive social security credit for the work they have done, even though in some instances the tax was withheld from their earnings. Many times employers simply forget to file the returns.

Thus, a domestic worker may lose out in the valuable coverage he or she is counting on for the future.

Barkley further stated that baby sitters are also in the category of domestic workers and the same provisions apply to them. In those situations where a baby sitter is paid \$50 in any calendar quarter, a proper re turn noting the name and social security number of the baby sitter, and the wages paid, must be filed with the Internal Revenue
