Social Security Questions & Answers

My claim on her earnings was work. My mother died when I turned down because she had not worked in the last 3 years of her life. Has the law been changed so that I may now qualify on her earnings?

www. My mother died when I was 17 years old, but my father's claim for me was denied. I do not know why. Would it do me any good to apply for benefits on my mother's record?

A. Recent changes in the law make it possible for children to qualify on their mother's earnings the same as on their father's earnings. You should contact your social security office and file a new claim.

A. Based on your question it is impossible to give a definite "yes" or "no" answer. The answer depends upon the amount of work your mother had under Social Security coverage. If she was fully insured at the time she died




