

PUBLIC HEARING

Notice is hereby given that the North Carolina State Highway Commission will hold a public hearing on the proposed expansion of the existing rest area located on the south bound lane of East of the South Carolina Line. The expansion will require additional right-of-way on the north and west side of the existing rest area right-of-way.

The hearing will also include the proposed combination Welcome Center and Rest Area on the north bound lane of I-85, 2.2 Miles North East of the South Carolina Line, in the close vicinity of the I-85 and NC 216 interchange. The proposed project will consist of buildings, parking areas, ramps to and from I-85 and the necessary right-of-way for the Welcome Center.

Sales Tax Deductions Are In Table
Greensboro, N. C.—The amount North Carolina taxpayers can deduct for sales tax on Federal tax returns can be found in tables printed in the 1040 tax instruction.
J. E. Wall, District Director of Internal Revenue for North Carolina, said the tables show the sales tax deduction by family size and income.
The table is based on consumer spending patterns and shows the average sales tax paid by North Carolina residents, he said.
The sales tax on automobiles purchased is not included in the table. Taxpayers who bought cars in 1969 may add deductible sales taxes paid on them to the amount shown in the table.
The table is furnished as a guide for the convenience of taxpayers who do not keep detailed records of payments. Taxpayers who prefer to deduct the actual amount of state sales taxes paid during the year should have records as proof of payment, Wall said.
In 1968, North Carolina led the nation in adult driver education with more than 49,000 individuals completing courses in defensive driving.
