Jaycee Rodeo Friday, Saturday

The second annual Blacksburg Jaycee rodeo will be held at Brown's Arena just off the old Chester highway on Aug. 20-21 at 8 p. m. each night. Signs will be placed in town to aid in direction to the rodeo.

This is a first class event which is sanctioned by the Southeast Rodeo Association. This same rodeo has played throughout the southeastern area this summer and most recently playing at Hendersonville before approximately 6,000 people on July 16, 17 and 18. In past weeks it has also played at Charlotte and at the Bristol Speedway in Bristol, Tenn. drawing huge crowds. This is the last rodeo site before the Southeast Rodeo Association championship finals are to be held at Love Valley, N. C. on Sept. 3, 4 and 5.

The rodeo features six big events which include bareback riding, calf roping, steer wrestling, girls barrel racing, goat tying and Brahma bull riding. Featured participants include Buddy Kidd from the Rock K Ranch in Charlotte in the calf roping event. Also Scott Tucker of Jacksonville, Fla. in the bull riding event, and Harold Boozer of Blythewood, S. C., in the bare back riding event. These men are current point leaders in the seven state Southeast Rodeo Association.

Other attractions include Bob Pressley, widely renowned rodeo clown; Edward Brown, local rodeo rider and a trick T-model car act.

Advance tickets can be purchased from any Jaycee and at the Iron City Pharmacy for 75 cents children and \$1.50 adults.

Other attractions on Saturday will be barbecue plates being sold by the Jaycees at Byars Super Market beginning at noon and throughout the afternoon at a parade through town at 2 p. m.
