

# Trail Map Available

A complete trail map of the Great Smoky Mountains National Park is now available in four colors along with a description of each campsite. Over 60 miles of the famous Appalachian Trail which runs through the Park has also been re-surveyed.

Until publication of the Great Smoky Mountains National Park trail map it would take

over 50 individual topographical and general maps to be able to locate each of the trails and campsites. Some of the topographical maps are over 20 years old.

This new map was developed through the efforts of a survey team from the University of Pennsylvania; personnel of the National Park Service and the publisher, Jones

Publishing Co. of Asheville, N. C.

Over 12 million people from all over the United States visit the Great Smoky Mountains National Park and unlike other national parks, the Smokies are heavily visited every month of the year.

Frequently rescuers and Park personnel are called upon to search for lost tourist and hikers. The Great Smoky Mountains National Park Trail Map is the most accurate and easy to read map available of the Smokies and is an aid to the casual visitor and to the experienced backpacker.

# Burlington Beginning Metric Conversion

Burlington Industries is beginning metric conversion.

Manufacturers of machinery, equipment and supplies are also being notified that the choice of standard or metric units for Burlington products will be available to customers no later than October, 1978. William A. Klopman, chairman and president, said, "This is the latest step in Burlington's planned, structured program to convert totally to metric in the years ahead. The move to metric is
