Crosby Returning Home To Kings Mountain

The Attorney General's Office announced today that effective Oct. 1 Assistant Attorney General Christopher Stephen Crosby will be leaving his post with the Department of Justice to return to the private practice of law in his hometown of Kings Mountain.

Mr. Crosby was appointed to the Justice Department two years ago and served as counsel to the Department of Human Resources and the State hospital system. His duties have included litigation, as well as legislative liaison with the General Assembly and the drafting and preparation of statutes.

Before coming to Raleigh, he was associated with the North Wilkesboro law firm of McElwee, Hall & McElwee where he was active in corporate law as counsel to Lowe's Companies, Inc. and Holly Farms Poultry Industries. Prior to that Crosby served as law clerk to Justice David M. Britt of the North Carolina Court of Appeals.

A native of Kings Mountain and the son of Mrs. Vernon P. Crosby and the late Mr. Crosby, he is a graduate of Kings Mountain High School and obtained his bachelor's degree in Political Science and History from East Carolina University. He received his Juris Doctorate from Wake Forest Law School and is currently a candidate for a master's in Public Administration from the University of North Carolina at Chapel Hill.

Attorney General Edmisten characterized him, "as an excellent

attorney and a valued and close friend. I am sure he will continue to render valuable service to the people of North Carolina. Cleveland County is indeed fortunate to have him home again. My only regret is that we could not keep him here in Raleigh. We support his decision to return to private practice and extend to him the very best wishes of this office."

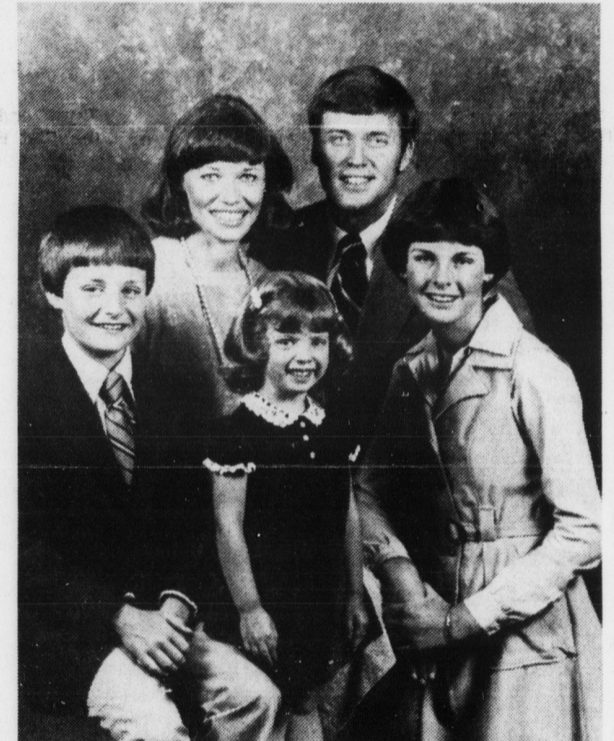

Hamrick Resigns To Campaign In Mayor's Race

Gilbert (Pee Wee) Hamrick, candidate for mayor, quit his job Friday with the city public works department to campaign for mayor. Hamrick, who made an unsuccessful bid for mayor four years ago, filed last week.

City personnel regulations prohibit employes from holding or seeking political office while employed by the city.

The Mayor's race is a three-man race, including the Incumbent John Moss, seeking a seventh and second four-year term at City Hall, and Jerry Mullinax, who previously made an unsuccessful bid for a seat on the board of commissioners.

Two other contests have developed in the Oct. 9 election where four seats are open. In District Four, Norman King is challenged by former city employe Dutch Wilson. Ward Three Comm. Corbet Nicholson is challenged by Ex-commissioner T.J. Ellison, Wayne Worcester and Lawrence Batty.

District One Comm. Jim Childers is unopposed for re-election to a second term.
