The examination tests knowledge and understanding of correct writing skills, social studies, science, reading skills, and mathematics. Upon successful completion of the examination the adult will be issued a high school diploma equivalency certificate by the NC Board of Education.

Satisfactory scores are permanently on file at the State GED office. Incomplete or unsatisfactory scores are valid for re-testing for a five-year period.

county during the hours the polls are open on election day and persons who are unable to go to the polls because of illness or physical disability may vote by absentee ballot during the period Sept. 5 to Oct. 29. Onestop absentee voting (voting in the elections office rather than having the ballots mailed) is permitted from Oct. 6 through Oct. 30, at 5 p.m.

The Cleveland County Board of Elections office will be open on Sat., Oct. 4, from 9 a.m. until 4 p.m. to register voters.


