dividual and his freedom. (3) It discriminates against the woman who bears the illegitimate child and lets the man go free. (4) It is unnatural and against the laws of nature. (5) The bill does not permit the incentive of redemption. (6) The bill goes against the idea that a man is innocent until proved guilty, it assumes a woman guilty until she proves herself innocent. (7) The cost for administering this bill will be just as great or greater than the present cost of welfare payments to mothers of illegitimate children.

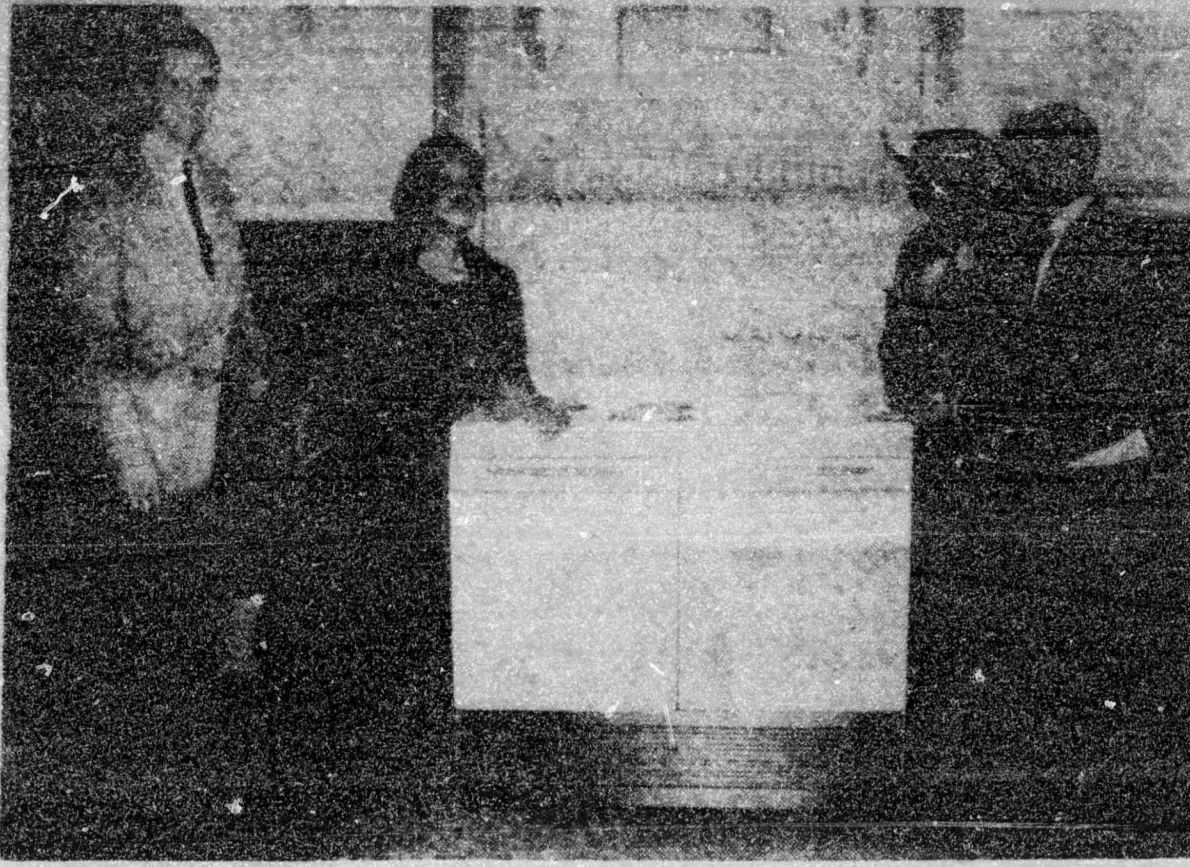
Church Bonus Money Rules

All purchase slips or receipts presented to your church must come from stores participating in the CAROLINIAN Bonus Money.
Each week carries a date in the Bonus Money period. Purchases eligible must come from the store during the week the "red" appears.
All purchases made during the Bonus Money period should be submitted. All receipts must come from individual purchases.
All churches in Raleigh and Wake County are eligible.
All purchase slips must bear the name of the store from which the purchase was made.
All purchase slips should be submitted in the name of the church, and should be in the office of the CAROLINIAN the Monday following close of the Bonus period.
In order that smaller churches may have an equal opportunity to share in the Bonus Money the following regulation is expedient: No church of over 200 members will be awarded its Bonus Money consecutively. If a church of 200 or more members receives its Bonus Money after the first period it would have to wait until the third Bonus period to be presented its Bonus Money, except where a church has 200 or less members, then it could win its Bonus Money consecutively. However, this does not mean that second and third awards cannot be sought consecutively. Consequently every church has the opportunity to receive an award every period.
No purchase of over \$100 from any one merchant during a week can be counted.
There is a ceiling of \$50 per person a week for purchases.
There is a limit of \$25 per person of purchases by store club members. The amount will be divided.
Weekly purchase receipts should be shown on each packet and total placed on the outside of the envelope carrying the person's check along with name and address.
Church bonus members will be announced in the same following the closing of the Bonus period.
All entries remain the property of THE CAROLINIAN.
No entries in that which the names of the Bonus Money winners are announced by THE CAROLINIAN, and no responsibility is accepted by THE CAROLINIAN for any entries.
The receipts from stores will be returned to the merchant on the following:

1. Unless the problem of illegitimacy is checked, a number of disadvantaged citizens will be born.
2. The bill does not take from the woman the right of appeal to the courts.
3. It will serve as a deterrent against "negligent sexual delinquency."
It will reduce the financial burden now borne by the state through payments of welfare checks to unwed mothers.
Rev. Robert L. Shirley, pastor of Raleigh's Davis Street Presbyterian Church, in behalf of the Ministerial Association, pointed out a series of technical inadequacies in the phrasing of the bill.
The question of what would happen if an out-of-state unwed mother brought more than two illegitimate children into the state was raised by Rev. Shirley. He stressed the fact that investigation by case workers would be unound, since it is presumed that the unwed mothers need psychiatric treatment.
To leave the matter totally up to the Euteneic Board, without the people being represented, would be undemocratic, said Rev. Shirley.
Representing the Colored Women's Federated Clubs was Mrs. D. M. Phelps who stated that this organization has been interested in this problem for sometime. While she did not bring an official report from this body, it was her feeling that they endorsed the proposals in the bill.
Dr. Rachel Davis, a leading proponent of the bill cited statistics showing that around 20 per cent of the persons involved in crime come from homes of illegitimate mothers. She added that 39 per cent of all inmates in our reformatories for youth were illegitimate children.
The Wake County Commissioners sent a representative who stated that the Commissioners were in favor of the bill. It was revealed that Wake County has an unusual financial load in supporting mothers with illegitimate children - a total of 639 children.
Dr. Davis was called to the microphone again to give the findings of her inquiry of the 100 boards of county commissioners in North Carolina. She stated that out of the 100 board, eight had no comment to make; four were not sure as to what position they should take; 77 boards endorsed the bill.
North Carolina has, for other reasons in the past, through the recommendation of State Euteneic Board sterilized persons on the grounds of feeble-mindedness, epilepsy, and mental illness. For instance, in 1935, 289 such individuals were sterilized.
The Euteneic Board is composed of five persons representing the Commissioner of Public Health, the Attorney General, State Health Officer, and Superintendents of Raleigh and Goldsboro State Hospitals.
Some 550 people were in attendance at the hearing, of which perhaps a dozen were Negroes.

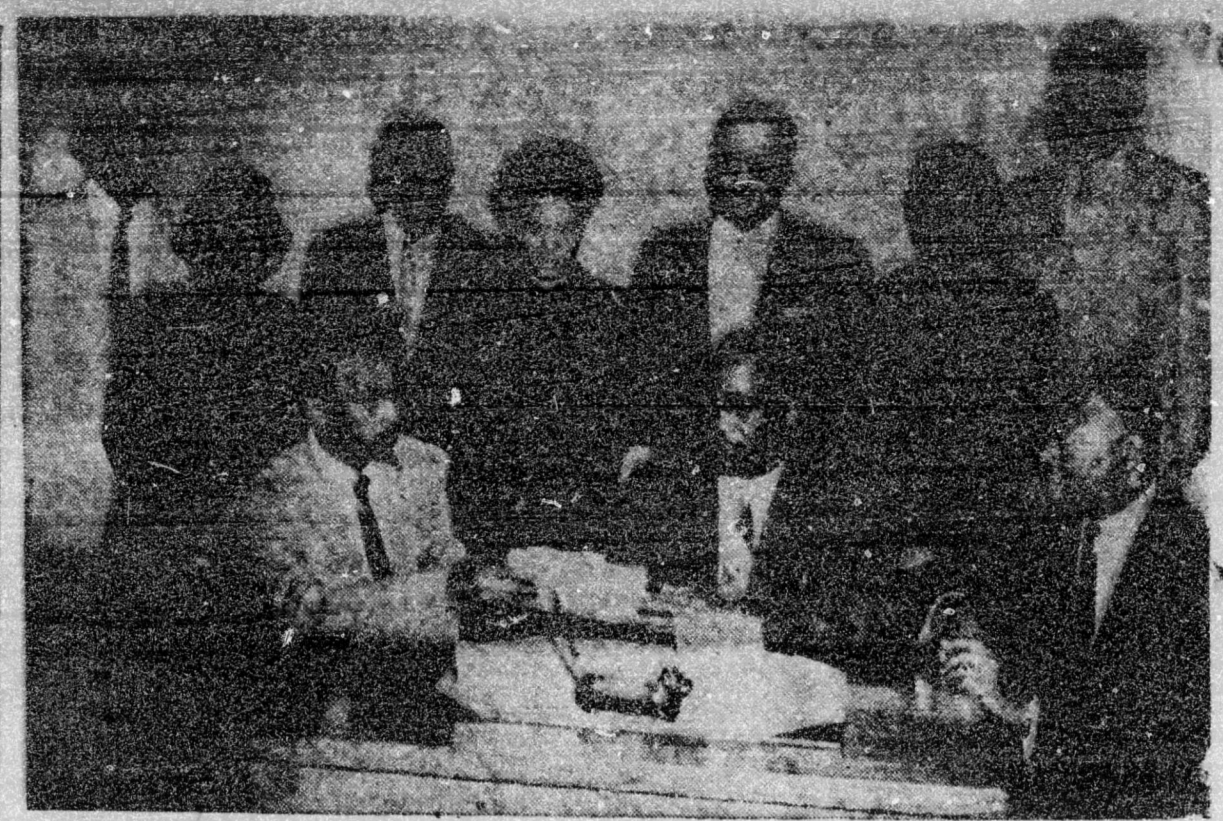

Agricultural Extension Service, because they do not produce enough to pay for the feed they consume, the housing they require, and the hours of labor spent in taking care of them.
"There is a definite correlation between keeping record and high production per cow," Wynn continues.
