Foundation – “Working hard, fast and right”

New Site Plan Overwhelmingly Approved

Resounding approval from all the participating institutions greeted the site plan presented by Don Lee and Rob Jolly of the firm of Dellinger and Lee. The plan (shown in the center pages of this paper) addresses itself to a number of issues and offers excellent solutions. The symetric balance of the proposed sites emphasizes the equality of the participating institutions. Children attending education classes in the education-recreation building will have easy walking access and a clear view of the sanctuaries. The full beauty of the complex and the prominence of the Temples will be oriented toward Providence Road for maximum impact. Athletic fields and courts will be placed in a setting especially conducive to quality participa-

tion and noise control. Finally, ample acreage has been left undeveloped in anticipation of future community needs.

Architects Proceeding With Plans For Education- Recreation Facility

Meetings held with institutional representatives, the Foundation Board and Building Committee Chairmen have resulted in approval for the architects to proceed with the development of working drawings. “The next week will be very busy for both the architects and the members of the Building Committees appointed by the institutions,” said Bill Gorelick, Building Committee Chairman. “We feel we have the full understanding and cooperation of the participants. There is a sense that this is the time, right now, to make

this project happen, and we are going to do just that. We are going to work hard and fast and right.”

Campaign Tops \$4.3 Million Kay and Gold Co-Chair Drive For Indoor Pool

Campaign Chairman, Harry Swimmer, recently made two dramatic announcements the first was a gift of \$50,000 from the Schwartz Family (Susan Roth, Nancy Sternoff and Elliott Schwartz) bringing the total to \$4,305,000 for the Capital Drive.

The second was the announcement of Barry Kaye and Mickey Gold as co-chairmen for the special drive to raise \$250,000 for an indoor swimming pool. These funds will be raised in the form of increases from persons who have already made a pledge to the Capital Drive.

Federation '83 Campaign Is Over \$712,000

“We have 170 more people to see in person and talk with by phone. When we are done we will have reached \$800,000.”

Ron Katz, chairman of the Men's 1983 Campaign, made this dramatic announcement at the March meeting of the Federation Board. In discussing the increase from the 1982 campaign (\$630,000)

he particularly noted the increase to \$60,000 in Women's Division. In the Spring of 1982 the Federation set its '83 goal at \$800,000 and the '84 goal at \$1 million. “We have no option,” said Richard A. Klein, Federation President. “We have the needs locally for a million dollar campaign and we have the capacity to


