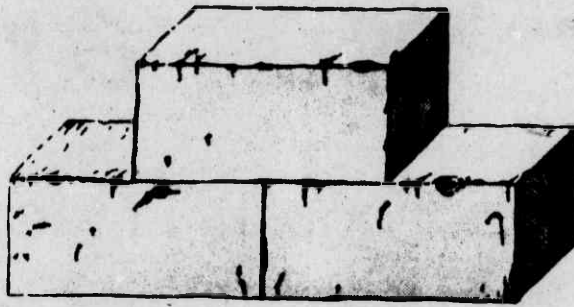
Special Olympics

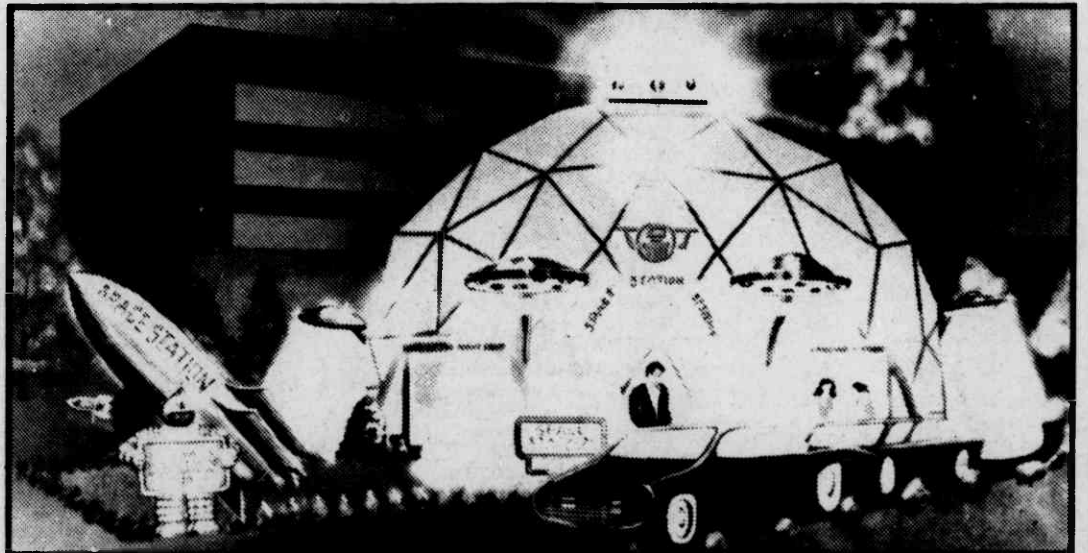
