Clear strategic motives explain the recent heinous attacks perpetrated by militant Palestinians against Israelis. Kill Jews; generate apprehension among Israelis; grotesquely illustrate that "armed struggle" against Israel is alive and well; incite dissension among Israeli citizens and between the general public and political lead-

ership - if possible, fray societal bonds; subvert Israel's May parliamentary election; demonstrate the incapacity of Israel's vaunted security apparatus to defend Israeli life and property; weaken, undermine, and halt the Arab-Israeli negotiating process; and, discredit any segment of Arab leadership which permanently or temporarily threatens to embrace an accommodation with Israel.

A chilling portrait for Israelis or for any civilized human being to visualize. It was believed by historians, politicians, and analysts that such repulsive accounts which chronicled Israel's daring struggle to exist, survive, and persevere were on their way for storage in archives.
