

Women's health access survey set to begin

DURHAM, NC-Research suggests that lesbians and other women who have women partners may have difficulty accessing medical care which is sensitive to their specific needs. They may not get regular breast exams, Pap smears, blood pressure checks or other care, often because they can't afford medical care, they don't know where to go for help, they're afraid of the results, or they have had bad experiences with health care provid-

To better understand the issues about medical care that women who partner with women confront, researchers in North Carolina will launch a major survey during Lesbian, Gay, Bisexual & Transgender Pride Month, June 1995. The survey, funded by the National Institutes of Health's Office of Research on Women's Health in Washington, DC, is being conducted by lesbian health workers, including staff from Duke University Medical Center and the University of North Carolina School of Public Health.

The project will target all women in North Carolina who have women partners or who identify as lesbian or bisexual. The researchers are especially committed to strong respondent representation among older women, women of color, low-income or working class women, women with disabilities, and rural women. They plan to use the information they gather to create education and outreach materials specifically designed for women with women partners, to inform them of what they need to know to stay safe and healthy. They will also use the information to teach doctors and other health care practitioners about lesbian health needs and how to give more sensitive care to their patients.

"This is a survey about the health needs, concerns and experiences of women who love women," says project coordinator Liza Rankow. "We may call ourselves lesbian, gay, bisexual, marimacha, in the life, or we may not identify with a label at all. We are different races cultures ages and abilities different races, cultures, ages and abilities. We come from different class backgrounds. We are rural or we live in cities. The purpose of this survey is to better understand our varied life experiences, our health risks and our ability to access the medical care we need and deserve."

The project, called Women's Health Access, is seeking women from all parts of North Carolina who are interested in helping to distribute surveys in their area. Both paid and volunteer positions are available. Women of color, rural women and older women are particularly encouraged to apply.
