The only Pre-Flighter with previous college track experience is Robert Gorman, who captained Dartmouth's football team in 1941, and who was a three-year letterman in track. He will participate in the broad jump.

Other Pre-Flighters who may cause the favorites trouble are H. S. Bunting and H. P. Hancock in the polevault, J. S. Kissel in the distance events, and E. R. Nuttall in the shot.
