Montreal

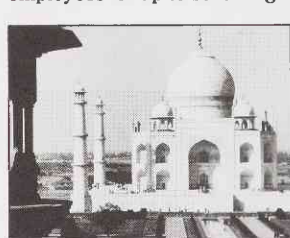
