POTTS ELECTED TO BOARD OF TRUSTEES - FUND DRIVE LETTERS OUT

At the Hospital Board meeting held Tuesday evening, Mr. Louis S. ("Bud") Potts was elected to the Board of Trustees. Honorary member of the Board, Dr. Herbert Koepp-Baker attended the meeting.

It was announced that the Hospital Fund Drive letters will be mailed on June 15th. A copy of this letter follows:

Dear Patron:

As in years past, Highlands-Cashiers Hospital is again making an appeal for financial support. It needs this help to remain in operation, as is the case in most hospitals. The established fees for services (patients' bills) are insufficient to cover the actual cost of maintaining the hospital 24 hours a day, 365 days a year. Welfare pays a fixed amount for indigent care of patients on its rolls but this pays only a part of the hospital's cost.

The difference between actual cost and income derived from patients and welfare is met by the free will contributions of those who are fortunate to be able to help.

In addition to needing funds to cover general operating budget, funds are needed for new equipment and betterments. The extent of these improvements depends upon the generosity of the community.
