### **Students Plan To Resign From Committees**

Students serving on institutional committees are considering resigning unless they receive full voting rights, according to Ken Wright, president of SGA.

Wright was quick to note that this was a last resort, and that student committee members will first go to their respective committees and ask for full voting rights.

"If full voting rights are not granted we will then decide on a course of action," Wright said. "But, resignation is a possibility."

Presently students have full voting rights on seven institutional committees. There are no students on the degree programs committee, and students may vote only on matters of policy in three other committees. Claude S. Ramsey Jr., of 9 Fairway Place, Asheville, who serves as chairman of the UNC-A Foundation's fund drive, gave \$3,000 to the Nixon campaign.

Ramsey, former head of American Enka, is now president of Akzona and chairman of the board of directors.

The other UNC-A contributor was Maurice H. Winger Jr. of 15 East Forest Road, Asheville.

Winger is a member of the UNC-A Board of Trustees, president of American Enka and member of the Akzona executive committee. Nationwide, the
