Fee Now Charged To Teachers

Dr. Bergemann, Chairperson in Department of Education, has announced that beginning October 1, 1975 a fee of \$10.00 will be charged for the processing and issuance of the initial North Carolina Teachers Certificate. The following communication was sent to Dr. Bergemann from Dr. Craig Philips, Superintendent of Public Instruction in North Carolina: North Carolina has never made any charges for the issuance of a North Carolina teacher's certificate. This has, in the past, been a service provided free by the State. It became

apparent in the last session of the General Assembly that the cost of issuing certificates which the State has borne was going to be shifted to the individuals for whom the service was performed. The State Board of Education has adopted a Certification Eee Schedule which is designed to underwrite the basic cost to the State of processing records and issuing certificates to individuals.
