In addition to the possibility of criminal prosecutions, gays should be aware that they may encounter discrimination in a variety of situations. North Carolina law does not prohibit landlords from refusing to rent because of the tenant's sexual preference. Hany leases contain clauses prohibiting the use of the leased premises for "illegal or immoral purposes," and landlords may use this provision as grounds for evicting gay tenants.

Gays may also be subjected to discriminatory practices when applying for credit. Lenders often consider gays to be unstable credit risks. As a result, if a credit check reveals that an applicant is gay, the lender may refuse to extend credit or may charge a higher rate of CONTINUED ON PAGE 6 (back page)
