## ACLU Told Where Homophobia Severe

Prompted by an inquiry from Dr. Arthur Finn of the Chapel Hill chapter of the American Civil Liberties Union (ACLU), persons attending the Feb. 20 CGA meeting showed concern at reports of UNC Athletic Department discrimination against students wanting to play varsity sports and have openly associated themselves with the CGA, TALF or like groups.

Problems with unfair negative clinical evaluations of openly-gay students in the health sciences and discriminatory professional licensing in North Carolina ("unsound moral character" has been tagged to gayness) were also cited as worthy of ACLU attention.

# Amnesty International and Gay Rights

Amnesty International, the human rights organization, and recent winner of the Nobel Peace Prize, has recently completed its annual International Council meeting to determine new policy. At the meeting, a resolution was proposed that Al define violations against homosexuals as a human rights issue.

#### We Salute Nebraska

Nebraska, the 19th state to repeal its sodomy laws, follows the lead of California, Colorado, Connecticut, Delaware, Hawaii, Illinois, Indiana, Iowa, Maine, New Hampshire, New Mexico, North Dakota, Ohio, Oregon, South Dakota, Washington, West Virginia and Wyoming.

Arkansas repealed its sex laws in 1976, but reinstated them in March 1977.

## First Gay VD Clinic in N.C. Begun

RALEIGH--St. John's Metropolitan Community Church and a local gay bar have obtained the cooperation of a local private health clinic to help combat VD in the area gay community.

The program includes a free, two-hour week-night screening and free treatment at the County Health Department or, for those persons who desire it, treatment at the cooperating clinic for a fee. The cost of the clinic is underwritten by the church and the bar, with equipment and materials provided by the clinic and the County Health Department.
