### MILITARY UPGRADES DISCHARGES

The deadline is January 1, 1980, for persons with less than honorable discharges from the military for being gay to have their discharges confidentially and automatically upgraded to honorable.

According to Gay Community News, a little publicized law (PL 9526) waives until January 1, 1980, the usual 15-year limit on the time a veteran has to appeal a less than honorable discharge.

Under new regulations adopted since 1978, persons separated from the military for being gay now typically receive honorable discharges.

Ernest L. Warren, Jr. was dismissed after having been found in a bedroom with a cross-dressed man during a police raid on a party in San Jose.

respective Congressional representatives to express their views on the anti-gay McDonald bill and the amendment to the Civil Rights Bill. The amendment has 50 co-sponsors.

NGTF has voted unanimously to endorse the march and to launch a national "Petition to the President" in connection with the weekend's events.

The petition asks Pres. Carter to:
1) issue an executive order barring
discrimination against gay women and
men; 2) endorse the Congressional bill
HR 2074, which extends the 1964 and
1968 Civil Rights Acts to include protection on the basis of sexual orientation.

NGTF observers said they have been impressed by the speedy establishment of a national network. "Coalitions have sprung up across the country and new gay groups are forming."

The delegates said "We must recognize that our strength lies in our diversity." Delegates in Houston were 50 percent men and 50 percent women, with third world representation.

The demands of the march are:
- a repeal of all anti-lesbian and
gay laws,

- the passage of a comprehensive lesbian and gay bill in Congress,
  - the issuing of a presidential executive order banning discrimination based on sexual orientation in the federal government, the military, and federally-contracted private employment,
  - the end of discrimination in lesbian mother and gay father custody cases,
  - the protection of lesbian and gay youth from any laws which are used to discriminate against, oppress, and/or harass them in their homes, schools, jobs, and social environments.
