## Campus Elections Friday — Vote!

### Voting Held Small Lounge Student Center

Campus-wide elections will be held on Friday, March 1 to elect 1963-64 officers of the St. Andrews Student Association. These offices include: President, Vice-President, Secretary and Treasurer of the Cabinet, Intramural Sports Council, Student Center Board, Student Christian Council; and two rising seniors, two rising juniors and one rising sophomore for the Honor Court. (The Honor Court will elect its President from the Junior and Senior members at a later time.)

Voting will take place in the small lounge in the Student Center. Each voter will be required to identify himself with his Concert-Lecture ticket (or in exceptions, some other valid identification.) The poll will be open from 8:30 a.m. through 5:30 p.m. on Election Day.

An Election Board comprised of Jim Bunnell, Honor Council President; Ralph Allen, Senior Class President; Wayne Ballard and Faye Hooks, President and Vice-President of the Student Association; Mr. Hiott and Dr. Harvin will supervise the elections.



**CAROL BROOKS**

Carol Brooks, candidate for the post of Student Association President, is basing her campaign on her experience as S. A. Treasurer in 1961-62 and Secretary this year. Carol served as Chairman of the Budget Committee last year, and more recently, on the Publicity Committee for the Christian Council.

**JOE CHANDLER**

Joe Chandler, seeking election to the Presidency of the Student Association, has represented the Junior Class on the Senate this year, where he was elected President Pro Temp.

Joe is the President of Orange Dormitory, serves on the Student Life Committee, and is Chairman of the Rules Committee. He has also held membership on the Freshman Orientation Committee.

### These Offices Are To Be Filled

#### The Student Association

**President:** The President of the Student Association is the official representative of the student body. He calls and presides over all meetings of the Cabinet and the Association, and expedites the operation of the Association by appointing necessary committees and filling positions (in compliance with specifications in the handbook) as the need for such action arises. The President is also a member of the Student Cabinet and the Student Life Committee.

**Vice-President:** The Vice-President of the Student Association assumes the duties of the President in his absence or at his request, and takes on the full responsibility of the executive position if for any reason the President must vacate his office. The Vice-President is a member of the Student Cabinet and President of the Senate.

**Secretary:** The Secretary of the Student Association prepares and posts the minutes of the Association and of the Cabinet, and handles all the correspondence of these organizations. Additional responsibilities include the communication of decisions and recommendations of the Association and of the Cabinet to the office

of the Dean of Students for appropriate action on behalf of the College.

**Treasurer:** The Treasurer maintains a permanent record of all financial transactions of the association. He formulates a budget for the coming year in consultation with the Student Cabinet and presents this budget to the Senate for action. He is responsible for making semi-annual reports to the Association and quarterly reports to the Senate. The Treasurer is required to submit his books to the Business Office to be audited once per semester. He is a member of the Student Cabinet.

#### The Honor Court

The Honor Court is the major student judicial body, with its members comprising partial membership of the Student-Faculty Judiciary Committee which hears all major cases, such as those involving the penalties of probation, suspension and expulsion. In addition, the Honor Court reviews reports from the dormitory councils and hears the cases of students who have reached the 20-merit deduction limit. The court hears appeals from the campus court and dormitory councils.

The officers of the following groups perform within their organizations the duties normally associated with their positions.

#### The Christian Council

The Student Christian Council coordinates campus religious activities and promotes Christian citizenship. The Council is responsible for providing students opportunities to enrich their Christian faith and to relate their faith to life both on and off campus. It is further concerned with ways and means of developing and undergirding campus citizenship.

#### The Student Center Board

The Student Center Board functions through the Office of Student Affairs in establishing guidelines and programs of activities and services which will serve the general welfare of the campus community.


Ned is a rising Senior from Winchester, Va.
