One of the items in the plat-

form of one of the candidates for President of the Student Association is a fire-evaluation and re-vitalization of the SCC." For those of us who are familiar enough with the Student Association to know what the SCC is, it is not surprising that this shoule be a part of a platform, not just for one candidate but for the entire Student Association next year. Many people have expressed a concern this year about the Christian Council, as well as about other organizations. Most of the complaints that I have heard have been only negative: "The Christian Council just hasn't done anything," There has been little or no recognition of things that have been accomplished and there have been no concrete suggestions as to what the Christian Council should be or should be doing. The Council is now working -- to top it off -against a kind of "image" which has developed around the Council in recent years, and this image, while not necessarily right or wrong, has nevertheless discouraged others from wanting to or being willing to work with the Council. It is no wonder that members of the SCC eventually become tired and discouraged and are tempted to let their work slide.

The Christian Council is obviously in desperate need of RE-EVALUATION and RE-VITALIZATION. If my program can be called a platform at all at his point, these rather vague and general terms would be the

The Christian Council on a campus such as ours, with C&C at the core of our curriculum,

must obviously play a role different from that of a Christian Council on a campus where "religion" is not one of the major emphases in the life of the school. We must make a serious effort to discover what our purpose should be, and then go to work to bring this purpose into action. It will do no good to philosophize all year and never translate our philosophizing into concrete actions; nor would it do any good to dive headlong into action without some serious thought and reevaluation of the Council's purpose on this campus. One solution would possibly be to concentrate for the remainder of this year on this re-evaluation and planning for the coming year and then--hopefully-- and with a little more enthusiasm, we might then be ready to begin our work for next year, never actually moving away from this framwork of self-

There are several concrete ideas which I would like to see developed for next year, in order to extend our program to more students. The SCC has a budget which would include enough money for several strong programs, if it is used. For the past two years, the SCC has left large amounts of money unused in their treasury, and this money could be spent for speakers in political, scientific, religious, art, or other controversial fields. The SCC could sponsor one or two regular-length movies as well as one or two special films and programs. Special work will need to go into plans for the Thanksgiving and Christmas seasons, because of the difficulties involved with the new calendar for these seasons. Other programs which will need continued planning and work are the Peace Corps, the Deputation Team, the Faculty - Home Seminars, the Tutoring Program under the Peace Corps, and so forth.

The Christian Council has the potentiality to become one of the most vital forces on this campus.

In filing for President of this Council, I have affirmed my will-ingness to do what I can to see some of this potentiality actualized. Your help and support will be greatly appreciated.
