To solve this problem and it is a problem, Hall mentioned that a proposal was formed to have the Faculty Executive Committee appoint 3 faculty members to the court during the spring term for the following fall.

As for the chair position, Hall said it was "traditionally" the second year student who held it. Currently there are no second-year students on the Court.

The Appellate Court is defined by the Saltire as the "highest judicial body consisting of students and faculty." The Court is supposed to receive the appeals from cases tried before the Dean of Students and Honor Court.

According to the Student Forum Minutes that were passed out recently, students are urged to read the 1986-87 Saltire. To quote the pamphlet, "students must implement the system and in order to implement the system they must **know** the system." Apparently, I find a slight contradiction in the system.

Election time is rolling around and once again apathy will rear its ugly head. Remember that these people that you vote for are the people that will run your system next year. Choose carefully and remember it's never to late to start a write-in campaign.
