WSSU Students Participate in UN Conference

On February 14, 1990, the North Carolina Consortium for International and Intercultural Education conference was held. This consortium links historically black private and public institutions with the United States State Department

The Model United Nations is sponsored by the North Carolina Consortium for International and Intercultural Education (NCCIIE). NCCIIE is a consortium of historically black colleges and universities in North Carolina, dedicated to promoting interest in and study of international affairs. The Consortium was founded by seven institutions, Bennett College, Johnson C. Smith University, North Carolina A&T State University, North Carolina Central University, St. Augustine College, Shaw University and Winston-Salem State University. NCCIIE is co-sponsoring this event with the Triangle Universities Security Seminar (TUSS), a consortium consisting of Duke University, North Carolina State University, and The University of North Carolina at Chapel Hill. The purpose of the meeting at WSSU was to select a Secretary General. The duties of the Secretary General at the Model United Nations are as follows: one, the Secretary General presides over the Model UN; two, the Secretary General will open the Model and deliver the Report on the Work of the Organization Speech, preside over the opening ceremony and all other ceremonies; three, the Secretary General will mediate and settle all disputes which may arise during the model, seeking the advice of advisers when necessary; coordinator of Political Science in the Social Science Department, said "the two WSSU students will assist the Secretary General because they were elected as deputies for the conference. In that conference, the students will actually assimilate the members of the United Nations duplicating in various activities and issues that pertain to overall global concerns." Johnson C. Smith will host the Model United Nations on April 6-7th. The required activities in the competition are as follows: one, a four-minute pre-prepared speech. (The speech should resemble a "State of the world" speech, identify-

and four, the Secretary General will deliver a closing speech reviewing the achievements of the delegates in the Model.
