Things were not always victorious for him. As a freshmen entering Winton-Salem State University in 1990, Gadsden had to compete against All-American wide receiver Yancey Thigpen; who presently plays for the Pittsburgh Steelers. But his biggest challenge came during the seventh game of the 1990 season. When Gadsden faced a career ending injury. In front of a

sellout Homecoming crowd, he made a terrific, twisting catch. He looked over his left shoulder and at the last second turned back to the right and made a spectacular catch but destroyed his knee in the process. Many fans doubted that Gadsden would ever play football again. " There was always doubt. On a scale of 1-10, my injury was 8.5 but when the doctor said that football was still a possibility, that was all the motivation I needed," said Gadsden.
