

An exhibit entitled "Rembrandt's Etchings and Drawings" opened for a two-week period of display in the Exhibit Gallery at Wesleyan College on April 16. The show consists of 50 items, chosen and arranged by the Rijksmuseum in Amsterdam with the intention of acquainting Americans with some of the lesser known works of Rembrandt. The exhibit is on loan from the Netherlands Infor-

brandt (1606-1669) is recognized as one of the greatest of the masters of both the brush and the etching needle. His great paintings are well known. No less important are his many magnificant etchings which alone would have established Rembrandt's name

Between 1626 and 1669, in the course of 44 years, Rembrandt executed about 300 etchings and 2,000 drawings.

## Dr. Gatewood Given Second Grant Of Year

Dr. Willard Gatewood, chairman of the Division of Social Sciences and Associate Professor of History at Wesleyan. has been awarded his second research grant of the year.


The first award was from the Harry S. Truman Library Institute for a study of the Truman Administration, and the second grant is from the American Academy of Arts and Sciences in Boston. The monetary grant is to be used for a study of the movement for a national university from 1800 to 1914.

Dr. Gatewood began research for the project about

two years ago, and the Academy grant is to continue rather than to initiate his recearch. The ultimate goal of the project is a publication of some sort. Dr. Gatewood expects to complete his work some time in the next three years, but as yet he has no definite schedule for the study.

The grant will provide opportunity for travel to Philadelphia, New York, and other cities where information is located, Dr. Gatewood's study will not be limited, but the available information is scattered in major libraries on the eastern seaboard.

#### **Required Exams** Set For May 7

The April 23 acclamation was not unanimous, and it ignored the SGA Constitutional rule calling for secret ballot. Furthermore, the election did not take into account all possible absentee

Nominations for the office of SGA president will be held again this Thursday after Chapel. A student body vote will be taken for the third time on Friday, April 26.

There were no conflicts in the election of vice-president and secretary, and the original winners will take their offices as scheduled. Robert Stephens, new SGA vice-president, is a rising junior, and he has worked as president of the Sophomore Class for the 1962-63 academic year.

He has also directed the activities of the Grievance Committee of the SGA, and he was a member of the important Ring Committee earlier in the year.

The new SGA secretary is Joan Lamberth, an experienced student government worker. Joan has served previously as secretary of the Association, president of Nash dorm, and chairman of the Student Life Association.

There has been discussion about the legality of the Student Life Association Attorney-General nomination, and the SLA is presently debating the question. Its decision will be posted as soon as it is available. Students presently nominated for the position are Dennis Schultz, Marshall Pridgen, and Doug Zellner.
