Honor and Affection Mark Davison Tribute


Set aside by the Medical Center and the University to pay tribute to Dr. W. C. Davison, the schedule of events October 4-8 was marked by a blending of honor and affection.

The central theme of the celebration was the symposium on The Commonwealth of Children. The symposium program, arranged by Dr. Jerome Harris, included excellent speakers from a number of disciplines and from various parts of the world. It was designed for a lay as well as professional audience, and underlined Dr. Davison's lifelong concern for the welfare of children everywhere.

The extra-curricular highlight of the weekend was a dinner in the Indoor Stadium attended by 974 guests. Amid affectionate testimony to his work and influence in many areas, Dr. Davison was presented with gifts: from alumni and friends, a Duke blue Lincoln Continental, a check for \$7,000 to be used in the Medical School as Dr. Davison wishes, and a scroll of the donors' names; and from the medical students, \$500 to establish a Davison Scholar program to allow one medical student a year to spend a quarter in a foreign medical school.

At a University convocation Dr. Davison received an honorary degree of Doctor of Laws. At this convocation President Hart announced that by unanimous vote of the University Board of Trustees the medical school building will be named the Davison Building.

The symposium concluded with Sunday morning Chapel service. Dr. James Cleland delivered the sermon on "Spiritual Aspects of the Commonwealth of Children."



Coordinator of Rehabilitation

DR. ROBERT A. GREGG has joined the Duke University Medical Center faculty as coordinator of rehabilitation with the academic rank of associate professor of physical medicine. Dr. Gregg will head the teaching program supported by the Office of Vocational Rehabilitation, U. S. Department of Health, Education and Welfare. Dr. James H. Semans, chairman of the Duke Medical Center's rehabilitation committee, said that Dr. Gregg will be responsible for coordinating and implementing the teaching of rehabilitation to medical students and will act as consultant to the various departments of the Medical Center.

Before joining the Duke faculty, Dr. Gregg served some two years as medical director of the Central Carolina Rehabilitation Hospital in Greensboro. He fills a position left vacant at Duke since the resignation of Dr. William D. deGravelles in 1958.
