Med Graduate Gets Silver Star

A 1966 graduate of the Duke University School of Medicine has been awarded the Silver Star for gallantry in Vietnam.

Capt. Earl W. Brian, Jr., a native of Raleigh, won the citation while serving as battalion surgeon of the 228th Aviation Battalion, First Cavalry Division.

The citation noted that during a rocket attack on Camp Martin Cox,"his extraordinary heroism was in keeping with the highest traditions of the military service and reflects great credit upon himself."

Following his internship at Stanford University Hospital in California and prior to his entry into the service Capt. Brian was named executive secretary of the California State Social Welfare Board by Governor Ronald Reagan. He is believed to be the youngest man ever to have held that post.

He is presently completing his military tour in Yuma, Ariz.
