General Assembly of North Carolina 1993 Session Ratified Bill

Section I 1 14-269.2 Chapter 558 House Bill 1008

An act to make it a class 1 felony to possess or carry a firearm or explosive on educational property or to cause, encourage, or aid a minor to possess or carry a firearm or explosive on educational property, to make it a misdemeanor to cause, encourage, or aid a minor to take or possess other types of weapons on educational property, to make it a misdemeanor to fail to store firearms in a reasonable manner for the protection of minors and to fail to warn a person of this law upon the sale or transfer of a firearm.

The General Assembly of North Carolina enacts:

Section 1. G.S. 14-269.2 reads as rewritten: "1 14-269.2. Weapons on campus or other educational property.

For a complete bill, check with Student Development Office. This act becomes effective December 1, 1993.

(a) The following definitions apply to this section:

(1) Educational property - Any public or private school building or bus, public or private school campus, grounds, recreational area, athletic field, or other property owned, used, or operated by any board of education, school, college, or university board of trustees, or directors for the administration of any public or private educational institution.

(2) Student - A person enrolled in a public or private school, college or university, or a person who has been suspended or expelled within the last five years from a public or private school, college or university, whether the person is an adult or a minor.

(3) Switchblade knife - A knife containing a blade or blades which open automatically by the release of a spring or a similar contrivance.

(4) Weapon - Any device enumerated in subsection (b) or (d) of this section.

(b) It shall be a Class 1 felony for any person to possess or carry, whether openly or concealed, any gun, rifle, pistol, or other firearm of any kind, or any dynamite cartridge, bomb, grenade, mine, or powerful explosive as defined in G.S. 14-284.1, on educational property. However, this subsection does not apply to a BB gun, air rifle, or air pistol.

(c) It shall be a Class 1 felony for any person to cause, encourage, or aid a minor who is less than 18 years old to possess or carry, whether openly or concealed, any gun, rifle, pistol, or other firearm of any kind, or any dynamite cartridge, bomb, grenade, mine, or powerful explosive as defined in G.S. 14-284.1, on educational property. However, this subsection does not apply to BB gun, air rifle, or air pistol.

(d) It shall be a misdemeanor for any person to possess or carry whether openly or concealed, any BB gun, air rifle, air pistol, bowie knife, dirk, dagger, slingshot, leaded cane, switchblade knife, blackjack, metallic knuckles, razors and razor blades (except solely for personal shaving), and any sharp-pointed or edged instrument except instructional supplies, unaltered nail files and clips and tools used solely for preparation of food, instruction, and maintenance, on educational proerty.
