how that system works," said Sugioka. "It's not an easy process to lead."

Many senators expressed concern about placing specific requirements on candidates.

"I think that in Senate elections the voters should be the ultimate decision-makers concerning who will or who will not represent them," said Community Concerns co-chair Tony de Velasco.

"I do think it could be helpful and I would like to see it strongly encouraged but I think the purpose of Senate is to represent the students," said Student Services Chair and former President James Green. "I think that requiring the president to have Senate experience is too limiting because it limits the candidates to a select group."

Green also said that the proposed addendum left "too much room for interpretation" because it does not specifically define "regularly attended" or specify whether or not a candidate must be an actual member of Senate.

The proposed change, which is the product of the Special Projects Committee's bi-annual examination of the constitution, also places

experience requirements for vice-presidential and treasury candidates.

"The work Laura and Bryan have done is excellent; it's constructive," said President Joy Jansen. "It's something I'm totally supportive of."

"The last two years have had quite a bit of turmoil in Senate," said Sugioka. "I believe that's largely due to inexperience with

Community Senate."

"It's not our job to decide who's qualified, it's the purpose of the election," said Green.

The Community Senate meeting Wednesday ended without a call for consensus.

"They still have a fundamental debatable political issue that hasn't been resolved," Olds said.

"Several senators spoke in terms of 'I feel' instead of having talked

SPECIAL PROJECTS COMMITTEE'S PROPOSED CHANGES FOR THE COMMUNITY SENATE CONSTITUTION:

1. Tickets are only required to carry a candidate for the offices president, vice-president, and a candidate for one of the two remaining positions, secretary and treasurer. The fourth member may be appointed.

2. "Presidential candidates shall have regularly attended Senate meetings for two full semesters upon taking office."

3. "Vice-presidential candidates shall have regularly attended Senate meetings for 1 full semester, or been on judicial or Res. Hall board for 1 full semester upon taking office."

4. "Treasurer candidates shall have two semesters of budget committee ex-

perience." (Candidates without this experience may petition to the election committee chair for suspension of the qualification.)

5. In special instances, potential candidates with outside experience may petition to Senate to have the qualifications suspended.

6. Students studying abroad must be given the opportunity to participate in elections.

7. In elections involving 2 or more tickets, "any ticket within 5% of the total votes cast of the leading vote-getter may ask for a re-vote" involving only the 2 leading tickets.
