lem girl these days! Yet, there is a common background to draw us into a close-knit community where we are able to share and enjoy many of the same.

(2) In today's terribly overcrowded world, family planning is one immediate means of controlling the population for the sake of our future survival. Shouldn't Salem students (supposedly the coming leaders in our modern society) be aware of this need and well-informed in this area so as not to contribute to the problem? The more available family planning services are, the more they will be used.
